In moste humble wise shew^th unto yo^e M^{ty}ship your dayly Orato^r Henry Ambler of Kighley in
the Countie of York husbandman that that whereas walter Paslowe of Kiddleston in the Countie
aforesaid Esquier and other were lawfully seised in their dema^sn as of fee of and in accontayne
ment wth thapp^tten^uce sett lying and being in Kighley aforesaid to thententt that he the said walter

and his said ffofferz shuld take the issues and Reverenue thereof and the offitte thereof Comyng
shuld bestowe and deservite yerely to go fyndyng of a prestes to sing masse in the Church of
Kighley aforesaid before the Image of our lady there And also of and in one pce of grounde
contaynyng by estimacion ij acres wth thapp^{er}ten^{ur} in Kighley aforesaid to thuse and intent hat go
said walter and his said Coofferz shuld wth go yerely reveenue thereof fynde a light or Torch
brennyng contynually before go Image of o^r lady aforesaid during go tyme of the xijth masse in
go same xijth Church to be celebrate and so seased devyded gr^{un}ted and leasid go same to yo^r
said Orato^r To have to hym for terme of contayne yeres not yet expired res^{er}vyng to the said
walter and his said Coofferz xvij^{sh} vi^d of rent payable at go feaste of whitson tyde and saynt
Martyn in wynter by even portons by force whereof yo^r said Orato^r entred in to go fynyssh and

the offitte thereof has perceably had preyed and taken wythe by the space of these xxⁱⁱ yeres or
more not only afore that of the dissolucion of Chauntries made the first yere of the reigne of o^r
Godaigu lorde the kynge that now is by which Acte all the fynyssh were vestide in the kynge
Maistie and yo^r said Orato^r become the kynge Tennt but also and sathens, Untill now of late
contayne riotous and evyll dysposed persons that is to say John Hall the yong^e Myles Hall and
Katherine Hall spyster in riotous maner wth force and armes disturbing the perceable possession of
the kynge Ma^{tie} and of yo^r said Orato^r entred into the pmisses breaking upp the hedge fence and
enclosures of the same And not wth that pleasade but also mowed and caried away oute of the said
pmisses the grasse and hay and the same wth force yet continually kepe and occupie to the evell
daungerous and pryevous example of other in suche like case the kynge tennt And forasmuche

as yo^e said Orato^e is a poore aged and ympotent pson not hab^e to labo^r psonally for his remedy in
yo^e pmisses It may therefore please yo^e wo^rshipfull M^e Shipp yo^e fynyssh and the kynges tytle
considered to graunte to yo^e said Orato^e yo^e kynges writ of P^rivie seale vnder the kynges
Ma^{te} seale of this honorable Co^{te} to be directed to yo^e said John, Myles, and Kateryne comanding eom
e eny of them to appere before yo^e good M^e Shipp at a certeyne daye and vnder a certeyne pain by
yo^e good M^e Shipp to be lymyted to answer to the fynyssh and fawth to abyde such order as by yo^e
good M^e Shipp shalbe lymyted and yo^e poore Orato^e shall pray to god for the p^rivie patron of yo^e good
